Prayers For Our Area

Pastor Chuck Bradbury offered this prayer practice:

"For the past 6 months Pastor Scott Kaczorowski and I have been prayer walking specific locations in the Wisconsin Rapids area on Thursday mornings. It is just like it sounds. We walk around a site and pray as we sense what God is leading us to pray for that particular place. A few of the places we have prayer walked include the Wood County Courthouse, City Hall/Police Station, the McMillian Memorial Library, Love INC, Hotel Mead and Conference Center, River Block, First Choice Pregnancy Resource Center, and Aspirus Riverview Hospital. It's different from praying from your home or church. One author described prayer walking as 'praying on site with insight.' Pastor Scott and I have proved that to be true on many occasions.

"As Pastor Scott and I do this regularly, we are finding that God is giving us a greater heart for the city. The Bible verse that we often refer to as we prayer walk is Jeremiah 29:7, 'Seek the peace of the city..., and pray to the Lord for it; for in its peace you will have peace.' "
